Special Instruction:

GENERAL TERMS AND CONDITIONS:-

- **1.** Incomplete application i.e. without copies of testimonials of prescribed minimum educational qualification, Date of Birth certificate and application fee etc. may render the candidate ineligible.

NOTES:
